

Results of Environmental Voluntary Plan

In 1993, we established the "Nitto Denko Environmental Conservation Activities Plan (Environmental Voluntary Plan), as specific guidelines to guide action in facilitating environmental protection activities.

Our Environmental Voluntary Plan will be amended to meet the demands of society and the times as needed.

In 1998, we added anew the topics of "attaining Environmental Management System ISO 14001" and "environmental consideration in countries outside

Japan development projects," reflecting the Nippon Keidanren (Japan Federation of Business Organizations) "Keidanren Appeal on the Environment" (Declaration of Voluntary Action of Japanese Industry Directed at Conservation of Global Environment in the 21st Century/1996). Currently, we have set targets for the years from fiscal 2005 to 2010 and each plant and business section/division have kept working on the achievement of the targets.
